### **TXOJ CAI/LUB HAUV PAUS NTAWM KEV NTSEEG**

Ascension Wisconsin (lub "KOOKHAUM") txoj cai yog yuav tsum muaj kev pabcuam thaum uas ti tes ti taw lossis lwm yam kev kho mob ceev uas nyob rau ntawm tej chaw kho mob. Txoj cai ntawm no yog lub hauv paus tsim los mus tswj thiab saib xyuas kev pabcuam nyiaj txiag rau cov neeg tuaj kho mob uas xav tau kev pab them lawv tej nuj nqis khomob uas tau mus kuaj los ntawm peb tej chaw kho mob ntawd.

1. Peb yeej muaj kev koom siab thiab pom tau tibneeg txoj kev txomnyem yog li ntawd peb thiaj li tswj txoj kev pabcuam nyiaj txiag kom pab tau, ncav txog, thiab faib kom mus cuag cov neeg txomnyem kom puas leej tau txais txoj kev pabcuam los ntawm feem nyiaj txiag ntawm no.
2. Txoj cai ntawm no yog kav txhua zaus uas thaum tibneeg tuaj cuag thiab nrhiav kev khomob ceev lossis lwm yam kev pabcuam kho mob ntawm peb lub koomhaum khomob no, xwslis ntsib tej kws khomob lossis ntsib tej kws nplig siab nplig ntsws ntawd. Txoj cai ntawm no yuav tsis hais txog tej kev uas lees hais tias yuav ua ib hli ib hli lossis maj mam them tej nuj nqis uas tsis yog thaum mob nyhav nyhav es tuaj khomob ceev ntawd.
3. Cov Chaw uas muab tau kev pabcuam Nyiaj Txiag Them Nqi Kho Mob muaj nyob hauv qab no. Nws yuav qhia meej hais tias lub twg yog lub pab them lub twg tsis pab.

### **NTSIAB LUS**

Hais txog ntawm Txoj Cai no, tej lus nram qab no yog lus tswj lus kav:

- **"501(r)"** yog hais txog xesees 501(r) nyob rau ntawm Internal Revenue Code thiab lawv txoj kev cai tswj.
- **"Tus Nqi Uas Kom Them"** lossis sau uas peb tug niam ntawv li no **"AGB"** txhais tau tias, hais txog ntawm kev khomob ceev xwb lossis tej kev kho mob uas yuav tsum kho sai thiaj yuav cawm tau tus neeg ntawd, tus nqi no yeej muab xa mus rau tus neeg kho mob ntawd lub esilans lawm thiab.
- **"Zej Zog"** txhais tias tau txais kev pabcuam kho mob los ntawm Ascension Wisconsin tej tsev kho mob thiab tej tsev kho mob me nyob ntawm ib cheeb tsam yav qaum teb Wisconsin, ntawm nruab nrab Wisconsin, thiab sab hnuv poob ntawm Wisconsin los mus rau sab hnuv poob ntawm Minnesota.

- **"Kev Khomob Ceev"** txhais tau hais tias tej mob no nws cia li mob loj zuj zus tuaj mus lawm thiab yuav tsum nrhiav kev kho mob pab kom sai li sai mas thiaj li kho tau, pab tau, thiab cawm tau. Tsis yog li ntawd ces tus mob ntawd nws yuav fuam loj zuj zus tuaj ces tej siab tej ntsws tej plab plaw thiab lwm yam ntawm lub nrog cev yuav tsis ua haujlwm zuj zus ntxiv tuaj.
- **"Tus Mob Yuav Tsum Kho Xwb "** txhais tau hais tias tus kws kho mob ua haujlwm thaum ntawd yeej paub meej lawm tias yog mob li cas thiab rawsli kws kho mob pom zoo ces yuav tau cia pw hauv tsev kho mob.

- **"Tus Neeg Mob"** txhais tau hais tias yog cov tibneeg muaj mob es tau txais kev pabcuam kho mob ceev lossis tej yam moj nkeeg uas tau txais kev kho mob nyob rau ntawm tej koomhaum tsev kho mob ntawd thiab tus tibneeg uas lees los nres yuav them tej nuj nqis kho mob ntawm tus neeg mob ntawm no.

### **Tej Kev Pabcuam Nyiaj Txiag Them Nqi Kho Mob**

Kev Pabcuam Nyiaj Txiag Them Nqi Kho Mob uas tau hais tseg hauv seem no yog pab rau cov tibneeg uas nws nyob hauv lub zej lub zos no xwb:

1. Cov tibneeg kho mob uas muaj nyiaj hli tsawg tshaj lossis tabtom ncav li ntawm 250 feem pua nyob rau ntawm Tseemhvw Txoj Kev Sojntsuam Nyiaj Txwm Xyoo (Federal Poverty Level), muaj feem txais kev pabcuam los them kiag kom tagrho 100 feem pua rau tus nqi kho mob ntawd tom qab uas esilans twb them tas ua ntej lawm yog hais tias muaj esilans pab them thiab.
2. Qhov uas muaj feem txais tsawg tshaj ntawd, cov tibneeg tuaj kho mob nyiaj hli yuav tsum nyob tshaj li ntawm 250 feem pua ntawm Tseemhvw Txoj Kev Sojntsuam Nyiaj Txwm Xyoo ntawd, tiamsis tsis pub tshaj li 400 feem pua, thaum no, mamli xam seb nws yuav raug them nqi kho mob ntau npaum li cas rau tej nqi mus kho mob ntawd thiab seb puas muaj esilans uas yuav them ua ntej es mamli tau txais txoj kev pabcuam. Cov tibneeg uas muaj feem rawsli hais ntawm no yuav tsis kom nws them tshaj li tus nqi uas lawv ua tuaj rau kom nws them ntawd. Yog tsev neeg coob tshaj li 8 leej rov sauv lawm, ntxiv \$4,420 rau ib tug tswv coob twg rawsli kev muaj feem poob ntawm 100 feem pua rau ntawm Tseemhvw Txoj Kev Sojntsuam Nyiaj Txwv Xyoo.

lb qho ntxiv thiab yog cov uas nyiaj txwm xyoo tseem nyob nqis tshaj ntawm 400 feem pua FPG thiab tus nqi khomob tsis tshaj li \$10,000, peb yuav tsis kom nws them tshaj li ntawm 25 feem pua tagrho ntawm nws li nyiaj txwm xyoo ntawd. (tsoomfwv qibsiab them tshiab Ob Hlis 1, 2019; nplai sau-tua feem pua hloov tshiab Lub Xya Hli 1, 2018)

3. Cov neeg kho mob uas muaj nyiaj tshaj li ntawm 400 feem pua lawm tejzaum tseem yuav tau txais kev pab kom luv tus nqi kho mob. Qhov no yog lov kom them 25 feem pua uas suav tagrho ntawm tej nyiaj hli. Tus neeg kho mob uas muaj feem “Seb Yuav Them Taus Npaum Cas” yuav tsis kom nws them tshaj li tus nqi uas lawv ua tuaj kom nws them ntawd.
4. Cov neeg kho mob uas muaj esilans tiamsis tsis nyob rau hauv peb tej Koomhaum kho mob, lub koomhaum mamli txo lossis yuav tsis lees thiab tsis pub kev pabcuam rau rawsli kev sojntsuam thiab tej mojkabsim tau hais tseg.
5. Kev muaj feem los thov kev pabcuam thov lub sijhawm twg los tau thiab mamli saib xyuas seb them taus li cas txawm li los yuav tsum tau leg tej ntaub ntawv “Thov Kev Pabcuam”).
6. Kev uas yuav muaj feem txais kev pabcuam them nuj nqi kho mob yuav tsum saib seb nws tus nqi kho mob ntawd ntau npaum li cas thiab seb nws nyiaj hli ntau npaum li cas thiab.

7. Cov neeg kho mob thiab lawv tsev neeg muaj kev thov kom rov saib xyuas dua ntxiv los ntawm kev tsis txaus siab txog ntawm txoj kev txiav txim los ntawm kev pabcuam tej nyiaj txiag them nqi muaj li nram no:

### **Lwm Yam Kev Pabcuam rau Cov Neeg uas Tsis Muaj Feem Txais Tej Nyiaj Them Nqi Kho Mob No**

Cov neeg mob uas tsis muaj feem txais pob nyiaj them nqi kho mob no, rawsli hais los sauv, tejzaum tseem yuav muaj feem rau lwm yam kev pabcuam uas muaj nyob rau hauv peb lub koomhaum. Cov kev pabcuam no nws muaj nyob rau hauv no, tejzaum yuav tsis rawsli tsab cai 501(r) tiamsis yuav tau muaj rawsli tej zej zog uas Ascension Wisconsin tau muaj kev kho mob rau.

1. Cov neeg kho mob uas tsis muaj esilans thiab tsis muaj feem txais kev pabcuam them nqi kho mob mamli txo tus nqi kho mob rawsli kev sojntsuam seb tej nqi uas them tuaj rau koomhaum qhov uas siab tshaj yog npaum li cas. Qhov uas them tuaj ntawd nws yuav tsum siab tshaj li lossis sib npog zog li 3 feem pua rawsli tej kev tsib nuj nqis los ntawm tej neeg kho mob los. Yog hais tias tus neeg mob no them twb tsis npaum li tej nqi uas them tuaj lawm yuav tsum muab txhua yam lov kom txwm li 3 feem puas nyob rau ntawm ib lub xyoos twg li.
2. Cov neeg mob uas muaj esilans thiab muaj uas tsis muaj feem txais pob nyiaj them nqi kho mob no tejzaum mamli kom them tus nqi kom tsawg. Tus nqi kom them tsawg no yuav muab qhia seb them npaum li cas ntxiv nrog rau tej kev pabcuam uas hais tias muaj thiab tsis muaj esilans li uas tau hais sau nqe 1 sauv lawm.
