THIS IS A PACKAGE PLAN THAT IS AVAILABLE TO THOSE PATIENTS WHO PAY THIS AMOUNT IN FULL PRIOR TO DELIVERY. PLEASE NOTE, IF THERE ARE COMPLICATIONS DURING EITHER THE MOTHER'S OR NEWBORN'S HOSPITAL VISIT, THIS PACKAGE WILL NO LONGER APPLY.

Vaginal Delivery and Newborn Care 2 Day Admit	\$4,800
Cesarean Delivery and Newborn Care 3 Day Admit	\$6,500

The OB package plan only pertains to Ascension Saint Thomas River Park Hospital charges and does not include any professional fees i.e. your physician, radiologist, anesthesiologist, pathologist, etc. Please note the OB package plan rates are subject to change and are not guaranteed until payment is made in full. **

Pre-Registration

- At any time, patients can Pre-Register online prior to delivery via the Ascension St. Thomas Website:

- Click on "Patient Pre-registration" and complete all required fields within the form. You will need to have your insurance information readily available.
- Patients may also receive an email or text to complete their Pre-Registration or verify that what was entered during the online pre-registration process is correct. This communication may be sent up to a week prior to your scheduled induction or estimated due date. Consent forms will also be signed at this time. If completing electronically, Insurance Card(s) and Photo ID will need to be readily available.

- Normal Cesarean Delivery and Newborn Care, \$6,500 package price, Regular price: \$17,619.50.

- Any patient who is a minor and covered under their parent's insurance will be covered; however, the newborn will **NOT** automatically have the same coverage. Prior to registration, please make insurance coverage arrangements.
